The Disc-Jockey shall provide all music, audio and/or lighting equipment (as requested) necessary to perform at Client’s date specific venue. It is further agreed that for any reason the Client’s date specific venue is canceled either by poor attendance, weather, police or any other reason not at the accountability of the Disc-Jockey, the Client is still liable for payment in full. For any of the Disc-Jockey’s equipment damaged or destroyed at the fault of the Client and/or guest, the Client is liable for the full amount of damages.

Payment by Client of remaining balance is due before starting DJ services. Failure to pay the remaining balance in full shall release the Disc-Jockey from furnishing any services to the Client under this Agreement. The deposit is non-refundable. Payments for the deposit or payments on account will be accepted by cash, check, and/or all major credit cards. This Contract is automatically active upon receiving the receipt of the deposit and contract. The Client agrees to pay a \$25.00 service charged for all returned checks. If by any reason the client and Disc-Jockey come to an agreement that client is ok to pay remaining balance in another date, the client is going to pay \$10.00 each day the full amount is not paid. The Client agrees to furnish a facility that completely covers the Disc-Jockey’s equipment from direct sunlight and rain. The Client agrees to provide specific directions to the event location, and access for the disc jockey’s set-up at least one full hour prior to the above stated contracted time.

This agreement cannot be terminated by any of the parties’ circumstances, but is subject to proven detention by sickness, accidents, equipment malfunction or acts of God beyond the control of the Disc-Jockey. In the unlikely event that the Disc-Jockey is unable to appear, the Disc-Jockey will make every effort to find a qualified substitute replacement. In the unlikely event that a replacement cannot be found, the Disc-Jockey will make a full refund of any deposit paid by the Client, however, the Client agrees that the refund will be the full extent of damages he or she is entitled to and no further damages may be sought against the Disc-Jockey. In the unlikely event that the Disc-Jockey is delayed and the event does not start on time, or time is lost during the event due to equipment malfunction, the Disc-Jockey will refund a portion of fees paid prorated to the time lost. This is the extent of the Disc-Jockey’s liabilities.
